2024 Superintendent's Report

2024 has been a year of God's favor and Kingdom advancement.

Together, we are making a difference in Colorado and Utah, and God has helped us make significant advancements in the Kingdom since the last year. I want to celebrate and report on a few wins in the last 12 months. If there was one scripture that summarizes the past year, I believe it would be Psalm 84:7.

"They go from **strength to strength.**" (NIV)
"They will **continue to grow stronger.**" (NLT)

"They journey from place to place, **gaining strength along the way.**" (The Voice)
"They will go from **power to power.**" (Aramaic translation: Peshitta)

I love this verse in relation to the last year because our momentum is growing and the Lord seems to be taking us from "strength to strength, power to power, and place to place gaining strength" (Psalm 84:7). Let me celebrate the strength and progress the Lord gave to us this past year.

- **1. Church Planting.** The following churches have been planted since launching our target communities in May of 2024.
 - Aurora, Colorado: Living Room Church (Vini & Amanda Bruno)
 - Commerce City, Colorado: Pillar Church (Alex & Margaret Reznichenko)
 - Greeley, Colorado: El Refugio (Cody & Emily Van Pelt)
 - Herriman, Utah: Cornerstone Church (Joss and Mary Walter)
 - Orem, Utah: Free River Church (Clinton & Jayln Ballew)
 - Peyton, Colorado: Riverstone Chapel (Tommy & Jenny Dunn)
- 2. Go Rural. The Go Rural Partners Fund continues to bless our rural churches.
 - Total income since inception: \$37,850.00 (1/1/24-12/31/24).
 - Total number of donors on the roster: 48 churches and individuals.
 - Total number of grants: 7 (full report at www.rmdc.org/gorural).
 - The total amount of grant money given all since inception is \$12,200.00.

3. Explore the Call Online Course. We completed a 34-session free online course, *Explore the Call*. This course is designed to help those exploring a call to ministry. An exceptional mentoring team consisting of Liz Jans, Dr. Kyle Chalko, Dr. Saehee Duran, and myself teamed up to present content in a casual conversation format. Participants can take their own pace, connect with regional mentors, or interact with a community of peers. The course is available 24/7 with topical sessions to help those exploring a call to ministry discern what God may be speaking to them. Local pastors now have an online mentoring tool to recommend to those exploring a call to ministry. It can be accessed at www.empowered.ag.

- **4. Leading Global Missions Initiative.** The Network has created a family of resources designed to invest in our lead pastors' ability to lead a mission's program with intentionality, effectiveness, and balance.
 - **Purpose.** The purpose of this initiative is fourfold.
 - Recognize and invest in lead pastors as the primary decision-makers and influencers on the local level.
 - Address fundamental changes in global missions over the last decade.
 - Bridge the gap between the different and, at times, conflicting needs of lead pastors and world missionaries that were identified in our network-wide survey.
 - Restore a needed emphasis upon increasing pledges to career missionaries working in and among the people they are trying to reach.
 - Paperback Book. Mark Renfroe and I co-authored this 150-page paperback book as part of the CTC series exclusively for lead pastors. This book is entitled, *Global Missions*: Leading with Intentionality, Effectiveness, and Balance and offers practical coaching to help pastors lead with intentionality, effectiveness, and balance. The book also offers practical and downloadable resources that can be customized to meet the unique needs of the local church. The book is now available on Amazon at https://a.co/d/2tnLPh9.
 - Online Course. With the assistance of John Easter (AGWM Executive Director) and AGWM liaison Steve Turley, I was able to write a four-session Zoom cohort that is interactive in applying the book's concepts, facilitating discussion, informing lead pastors, and incentivizing pastors to take the course. Those who complete the foursession cohort will receive a certificate of completion and access impressive incentives, including free video training from leaders like Rod Loy, John Lindell, and Rob Ketterling on practical ways to increase their church's tithes and offerings. These incentives will ONLY be offered to lead pastors who complete the course. The online course will be free on our LMS at https://empowered.ag.
 - Intermountain Collaboration. The Montana, Southern Idaho, Wyoming, Rocky Arizona, New Mexico Mountain, and District/Ministry Network Superintendents have partnered together to co-present the content in the first ever intermountain partnership of Networks from the southern border of Canada to the northern border of Mexico. All these mountain networks combined can make a huger impact upon 651 churches, 2,251 ministers, and 166,387

constituents. This is a huge win for missions in the mountain region.

- Blog Series. A six-part blog series entitled, "Level Up Your Global Missions" has been created as a companion resource in this initiative. The series presents practical solutions to the, at times, conflicting needs that exist between lead pastors and missionaries. The blog series can be accessed at www.generoncone.org/missionslevelup.
- **5. CTC Cohort.** Since its inception four years ago, the Crabtree School of Lead Pastors has blessed us.
 - 83 graduates and 16% of our minister's roster.
 - 35 (42%) graduates who are already lead pastors.
 - 20 (24%) female graduates.
 - 6 (7%) female graduates who are lead pastors.
 - New textbooks Minister Retirement, Isolation in Ministry, and Global Missions.
 - Series of short paperback books as companion resources for each topic addressed.
- **6. Learning Management System.** A Learning Management System (LMS) is a software platform or application used to deliver, manage, and track educational content and training programs. RMMN created an LMS in the fall of 2023 to launch our Retirement Essentials course. This past year three more courses have been added. The following courses are on our LMS at www.empowered.ag.
 - Explore the Call Course
 - Leading Global Missions Course (Summer of 2025)
 - Retirement Essentials Course
 - Increasing Your Church's Tithes and Offerings (TBA in 2025)

- **7. Retirement.** Empowering the RMMN ministers with the ability to retire with peace, freedom, and dignity. God has helped us further enrich the lives of our ministers in the following ways in 2024-2025.
 - 118 people completed the *Retirement Essentials Course* in 2024.
 - 5 copies of *Stewarding the Future* books (for board members) sent to every RMMN church (825 copies).
 - 2 copies of the book *Minister Retirement* sent to every RMMN minister (six months apart) totaling 1,080 copies.
 - The *Retirement Essentials Course* has been added to the CTC Cohort syllabus as a required out-of-class assignment.
 - The following progress has been made in partnering with CEP to help our ministers set up retirement saving accounts as of January 1, 2025.

- 8. Membership Class in a Box. To help our Network of affiliated churches advance to General Council status, the Superintendent's office created a membership class called "Discover Our Church" that can be customized to meet the unique needs of individual churches. The class is designed for a lunch or dinner meeting jam-packed with delicious food, fun activities, interactive table discussions, and a short vision and doctrinal presentation. The event is about two hours long and can be used in churches of all sizes around one round table or as many as they need to accommodate their group. While pastoring in Aurora, Colorado, I used this format to usher many new people into church membership. Everything is provided, including a complete script that can be customized, helpful downloads, and different options for pastors to choose from. This model only requires enough round tables that seat at least six people. That means our churches can hold a membership class as small as six or as large as they need. It can be held at the church, a recreational center, or even as a banquet in an event center. The Network has provided an order of service, written script, and downloadable resources to facilitate this two-hour, fast-moving, and action-packed event. - **9. Topical Resources.** The following series of researched resource books and articles were created and made available to our ministers.
 - Paper and Kindle Book Resources Created in the Past Year.
 - *Mentored Succession* was mailed to all lead pastors and can be accessed at this link.

- *Isolation in Ministry* added to CTC curriculum and accessed at this link.
- Global Missions added to new missions class on LMS and accessed at this link.
- *Minister Retirement* was mailed to all lead pastors two times and can be accessed at this link.
- Stewarding the Future can be accessed at this link.
- Shepherds of God was given to all ministers during the 2024 Sectional Tour and accessed at this link.

The following twelve districts have used one or more of these books for their ministers as well: Appalachian, Pen Florida, Northern Missouri, Northern New England, Oregon, Potomac, Southern Idaho, West Texas, Arizona, New Mexico, Iowa, and Church Extension Plan sent the Spanish version of *Minister Retirement* to all Spanish speaking Networks.

- **Level Up Your Board Meeting.** Board meetings often reflect a leader's confidence in and need for others. In this blog series, Gene examines five important areas to level up your board meetings.

- **10. Cedaredge Capital Improvement.** I am thrilled the Lord allowed us to close on the Ouray sale despite a squatter and last-minute challenges. I have requested Samuel Engineering, who we contracted to be the official owner representative on the chapel renovation, and asked them to prepare a schedule and updated financial impact report.





Independent Auditors' Report

Opinion

We have audited the accompanying financial statements of Rocky Mountain District Council of the Assemblies of God, Inc. dba Rocky Mountain Ministry Network (a Colorado nonprofit organization), which comprise the statement of assets and net assets - cash basis as of December 31, 2024, and the related statement of cash receipts and disbursements - cash basis for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the assets and net assets of Rocky Mountain District Council of the Assemblies of God, Inc. dba Rocky Mountain Ministry Network as of December 31, 2024, and its cash receipts and disbursements for the year then ended in accordance with the cash basis of accounting as described in Note 1.

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Rocky Mountain District Council of the Assemblies of God, Inc. dba Rocky Mountain Ministry Network and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Accounting

We draw attention to Note 1 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the cash basis of accounting described in Note 1, and for determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Organization

The Rocky Mountain District Council of the Assemblies of God, Inc. dba Rocky Mountain Ministry Network (RMMN) began on March 1, 1918, under the name The Colorado State Council of the Assemblies of God. It was established for the purpose of providing a formal organization for Churches and ministers who desired affiliation with the General Council of the Assemblies of God. In August 1923, the District was called the Intermountain District Council and in the summer of 1924 the name reverted to The Colorado State Council. Subsequently, on August 24, 1926, the states of Wyoming and Utah were added to the District and the name was changed to The Rocky Mountain District Council of the Assemblies of God. The District incorporated as a Colorado corporation on January 26, 1932. In 1949, Wyoming seceded and fanned a separate District leaving the states of Colorado and Utah as The Rocky Mountain District Council of the Assemblies of God. On April 21, 2015, The Rocky Mountain District Council of the Assemblies of God in Session approved a resolution adopting the 'doing business as' name of 'Rocky Mountain Ministry Network of the Assemblies of God.' The Council also approved a second resolution changing the title of Superintendent to 'Superintendent aka: Network Pastor.

The accompanying financial statements include only the cash receipts and disbursements of funds handled by RMMN office. Such funds include the General Tithe Fund and funds for various departments.

Income Taxes

RMMN is exempt from income taxes under Section 501(c)(3) of the Internal Revenue Code (Code) and Colorado state law, and contributions to it are deductible within the limitations prescribed by the Code. The Church has been classified as a publicly supported organization which is not a private foundation under section 509(a) of the Code. The Church did not have any material unrelated business income tax liability or uncertain income tax positions for the year ended December 31, 2024. The Church is generally no longer subject to examination by the Internal Revenue Service for years before 2021.

Basis of Accounting

RMMN's policy is to prepare its financial statements on the cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). Under that basis, the only assets recognized are cash and investments, and no receivables or liabilities are recognized in the financial statements. All transactions are recognized as either cash receipts or disbursements. Cash receipts are recognized when received rather than when earned, and cash disbursements are recognized when paid rather than when the obligation is incurred. Noncash transactions are not recognized in the financial statements. Under the cash basis, RMMN has elected to omit the presentation of expenses on a functional basis.

Basis of Accounting (continued)

The significant differences between cash basis and GAAP in RMMN's financial statements are:

- Property and equipment. Under GAAP, the cost of property and equipment is reflected as an asset and depreciated over the estimated useful life. The estimated cost of property and equipment was approximately \$1,153,000 as of December 31, 2024.
- Loans. Under GAAP, loans are reflected as a liability and reduced as principal payments are made. As of December 31, 2024, RMMN had vehicle loans with a total outstanding principal balance of approximately \$39,000.

Cash and Cash Equivalents

Cash and cash equivalents include investments in highly liquid debt instruments with an original maturity of three months or less, including certificates of deposits. At times operational cash needs will result in cash balances in excess of insured limits. RMMN is selective in choosing financial institutions with which to maintain accounts.

Investments

Investments consist of certificates of deposit with interest rates ranging from 3.75% to 6.25% and are held at the AG Loan Fund and the Church Extension Plan, an Assemblies of God organizations and are valued based on the cost basis. RMMN intends to hold all investments to maturity, and RMMN is not aware of any credit losses. The weighted average time to maturity for investments held at December 31, 2024 is 5.6 months.

Classes of Net Assets

The financial statements report amounts separately by class of net assets.

Amounts <u>Without Donor Restriction</u> are those currently available at the discretion of the Board for use in RMMN's exempt purpose and those resources invested in property and equipment. Amounts <u>With Donor Restriction</u> are those which are restricted by donors for specific purposes or with a stipulated time restriction. When a donor restriction expires, that is, when a stipulated time restriction ends or purpose restriction is accomplished, net assets with donor restrictions are reclassified to net assets without donor restrictions.

Board designated net assets consist of amounts designated by the Board for the use of Minister Resources and retreats.

NOTE 2 - LIQUIDITY OF RESOURCES AND AVAILABILITY

As part of RMMN's liquidity management, it has a policy to structure its financial assets to be available as its general expenditures and other obligations come due.

NOTE 3 - RETIREMENT PLAN

RMMN contributes 7.65% of each eligible employee's salary, employed at the District office, to the Minister's Benefit Association (an Assemblies of God entity). Eligible employees may elect to make additional contributions. Retirement plan contributions, including participating RMMN MBA enrolled ministers, for the year ended December 31, 2024 were \$135,581.

NOTE 4 - RELATED PARTY TRANSACTIONS

RMMN had related party transactions with the General Council of the Assemblies of God (General Council). The General Council periodically pays RMMN an administrative fee or reimburses RMMN for expenses incurred that benefited the national office. All ministers through RMMN also pay monthly dues to the General Council. Amounts received from and paid to the General Council for the year ended December 31, 2024 were \$123,907 and \$83,551.

AG Financial, which is a subsidiary of the General Council, maintains the money market account and certificates of deposit. Amounts held with AG Financial as of December 31, 2024 is \$140,731.

District Churches have several transactions with RMMN, such as tithe and offerings and monies used for the purchase of property. The amount received by RMMN from District Churches for the year ended December 31, 2024 was \$228,332. Occasionally RMMN assists struggling Churches or Churches in need. The amount given to District churches for the year ended December 31, 2024 was \$371,052.

RMMN's superintendent is a member of the Board of Church Extension Plan (CEP) which issues Church builder certificates. The certificates are similar in purpose to U.S. Treasury Notes and are required by CEP when a local Church applies for a loan. RMMN holds Church builder certificates occasionally to assist Churches in their building program. Total amount held by CEP as of December 31, 2024 is \$1,831,709.

Amanda Robinson now serves as our Women's Coordinator and has done a tremendous job building her team and casting vision for the future of women's ministry. Amanda and her team

are planning two AMAZING Ladies Retreats in the fall for CO and UT. These are DO NOT MISS events! We also brought on Isaiah Magaña, who now serves as the Assistant Church Ministries Director. Isaiah brings a fresh side of technical skills and creativity to this role that will help guide this next season of ministry.

We thank Forrest and his family for his hard work and the many campus missionaries, clubs, and salvations that have taken place during his ministry. Now Josh and Liz Jans take the reigns and will take Rocky Mountain Youth Alive to new heights. Josh and Liz have been in our Network for over 12 years and will build upon the foundation that was laid here in Colorado and in Utah. The best days are ahead for Rocky Mountain Youth Alive!

Missions Update

The Church Ministries Department has the privilege of overseeing five missions arms of fundraising to help our missionaries. In the past six years (since 2019) through Speed the Light, BGMC, One a Week, Light for the Lost, and Master's Toolbox... \$1,904,418.38 has been given from kids, students, women, men, royal rangers, and the local church! You read that number correctly... This is INCREDIBLE!

Next Gen Enrichment Counseling Scholarship Fund

Last year, we had a generous donor that wanted to give to something special that would make a lasting impact. After much thought, we all decided on a Next Gen Ministry Enrichment Counseling Scholarship Fund. We offer any Rocky Mountain youth pastor, kids pastor, or young adult pastor three counseling sessions with a licensed Christian counselor of their choice for free! We have heard a lot about mental health, emotional health, and marriage health in the past few years, but Rocky Mountain Next Gen is doing something about this epidemic. LEADERS, YOU ARE NOT ALONE, thanks to a generous donor, we now have over \$25,000 and growing of funds ready to help you.

Resources and Trainings

The mission of the CMD is to Equip, Train and Resource the ministries of the local church. In 2024, we released 52 resources that directly helped the local church. Resources and trainings such as Next Gen Sexuality Webinar, Adult Discipleship Webinar, Lead the Generation Vitals, KidMin Roadmap a five year KidMin strategy, marriage resource, worship resource, prayer resource, BIG days like Christmas and Easter checklists, men's resource, women's resource, background checks, mandatory reporting and so many more. Called Apprenticeship

We now have over 47 high school juniors and seniors from 20 churches who have gone through, or are currently going through, our 10-week apprenticeship that helps students explore their calling and take the next steps to enter the ministry.

Summer Camps and ONE DAY Utah

Camp season is always the highlight of our year. We already have over 1,500 students RSVP'd for four youth camps. We have 405 kids RSVP'd for Colorado Kids Camp and we are expecting over 250 for our NEW Utah Summer ONE DAY event. For the first time we will have over 2,100 kids and students from over 70 different churches attending our summer camps this year!

Partnered Men's Events

Rocky Mountain Network and Church Ministries has partnered with churches who are doing GREAT men's events. We have come along side them to promote their events to two regions of our Network. This year, once again, we partnered with pastor Josh Cook of Victory Life Church on the west slope and with Pastor Rob George of Christian Life Center in Layton, Utah. These events saw well over 750 men come together in worship, prayer, and fellowship! They have been a game changer when it comes to providing quality and experiential ministry to MEN! We look forward to finding a partner on the Front Range in the near future.

What God has done in the past six years is remarkable. To God be the glory!

- •New Missionary Staff The summer of 2024 saw Utah Chi Alpha gain five additional missionary staff. Currently, there are nine Chi Alpha Utah missionary staff. We continue to pray a Luke 10:2 prayer every day at 10:02 for more for every campus.

The harvest is great, but the workers are few. So, pray to the Lord who is in charge of the harvest; ask Him to send more workers into His fields.

- •Evangelical and Latter-Day Saint Dialogues We continue to be a part of "religious dialogues" at Brigham Young University and the LDS "Institutes of Religion" on college campuses. These are often deep theological conversations where students boldly share fundamental differences in loving ways. We pray that these conversations at the very least are like "leaving pebbles in their shoes."
- •Spring Break Missions Teams We hosted five missions teams from other Chi Alpha fellowships. They assisted in outreach on the campuses at Utah Valley and the University of Utah. Students from Duluth, James Madison (VA), Central Washington, Montana State, and Helena shared the gospel and grew in their burden for the LDS people. Hosting teams continues to be a key part of adding to our Campus Missionary in Training Program and potential missionary staff.
- •Church Plant in Orem Chi Alpha fellowship at UVU was able to partner with Clinton and Jayln Ballew to help plant a church in the Orem-Provo area. We are excited to have an Assembly of God church near the campus again!
- •Healthy Student Leaders A key ingredient in any healthy Chi Alpha are student leaders that are growing deeply in their walk with God and are also taking the Great Commission to make disciples that make disciples seriously. The covid years put a lull in the momentum, but we are now seeing student leaders replicate themselves at a faster rate than even prior to 2020. Some of these student leaders are the ones that will become campus missionaries in training and Chi Alpha and World Missionaries.

Prayer Points:

•Philippines Missions Trip - In July, seven students and two staff will travel to the Philippines to help Tom & Connie Bohnert establish a new work in what they call the "last frontier" amongst a Muslim village in Palawan.

- •New Student Leaders Trained Summer is the season for training as we equip new and returning student leaders for the upcoming school year. This year we will be adding five new student leaders at UVU and three at The U.
- •Laborers for the Harvest As we train new campus missionaries through the CMIT Program and host missions teams, pray for more missionaries for the universities of Utah.

As we have stepped out in faith, we knew this was a year where we couldn't let the things we weren't able to do keep us from doing what we were able to do. We've witnessed God's provision and help navigating through all of the intensity of the guest schedule combined with the project goals and deadlines that came with the improvements we set out to make. The result has been many great improvements in the facilities, but also improvements in volunteerism, staffing, strategy, and investment into your campground and the life transformation that accompanies a healthy camp ministry.

In the past year, we've been able to improve several areas at your camp facility. These include, but are not limited to:

- A new, larger, concrete patio to replace the rotted-out lumber deck adjacent to the snack bar.
- Expansion of Sweet Shoppe space.
- Completion of the new "bunkhouse" as a retrofit of the old game room.
- A new game room facility more than doubling the capacity of the old space.
- Several big maintenance fixes campus wide.
- New full hookup RV sites being finished.

New Internship Identity:

Our internship program has been a mainstay of staffing for our team over the years, and we are moving toward a new identity with that program which better fits the nature of the work that these special young people do in the stewardship of your camp. The new name for the internship is the "Upstream Ministry Team." We would describe the role of these important team members as investors and missionaries more than we would describe them as traditional interns, so we are moving away from that kind of description toward a new identity as ministry team members.

Volunteer Involvement:

This past year has seen the most volunteer traffic of any year since my involvement with the camp. Between the RV volunteers, the participation in events such as Camp Investment Week and Camp Prep Week, as well as folks plugging in to help us staff the local school events, etc., we've nearly doubled our volunteer base since years gone by. What a blessing it has been to see our Network rally in this way to take ownership of this special place. We have been so encouraged to see it. Thanks to everyone who has played a part in this ownership aspect and helping us continue to steward this special place well to God's glory.

TRINITY BIBLE COLLEGE AND GRADUATE SCHOOL



Spring 2025

This past year has proved to be a very good one for your college. Even a cursory examination of the key factors that determine institutional health shows good progress. Thank you for your support over the past year, and I trust the following is insightful as you continue to pray and assist us in our mission.

- Continued Enrollment Growth. As the higher education sector in general faces what is now known as the "enrollment cliff," it is very gratifying to note that Trinity Bible College and Graduate School retains a positive enrollment growth. Traditional undergraduate studies remained consistent with the previous year. The Pack Your Bags program had a smaller intake but remained completely viable. Encouragingly, our online programs have seen consistent growth, and our Graduate School has enjoyed exponential growth. We remain vigilant in the area of enrollment. Multiple factors can impact us from year to year, but Trinity continues to show remarkable resilience as it fulfills its mission.
- **Experiential Learning.** Central to our educational philosophy at Trinity is the need to not only educate, but also to train. In other words, to ensure the development of character and capabilities that ensure graduates can face real world issues. Thousands of miles have been traveled, GO Trips continue to be central to our annual calendar, and students have served in internships within the US and around the world. We remain unapologetic about ensuring that servanthood and commitment in the lives of our students is central in all we do.
- **Consistency in Staff and Faculty.** An indicator of institutional health is a low turnover in staff and faculty. This year we had several complete twenty years or more of service. Carol and I have completed nearly thirteen years. We are grateful to serve with a dedicated team.
- **Expansion of Accreditation.** The Graduate School at Trinity has now achieved Associate Status with ATS (Association of Theological Schools). We were approved to fast track the process to fully accredited status and anticipate this being awarded in just over one year from now. This makes us one of the few institutions in the upper Midwest that holds this prestigious seminary accreditation status.
- Success in the PhD Program. This May will see the first group of students graduate with the PhD degree. Trinity offers a rigorous research-based PhD and is currently producing some very cutting-edge research, especially as it relates to our Pentecostal world. Those graduating will receive the first ever PhD degree in Theology conferred in the state of North Dakota.
- **Financial Stability.** Thanks to an extraordinary group of generous donors and careful stewardship, Trinity remains debt free and cash flow positive. This is to be celebrated.
- A Special Appeal. I conclude this report by expressing my gratitude to the Rocky Mountain Ministry Network for its ongoing support. However, after 13 years serving in this role, it is disturbing to me to note that the level of support for Christian Higher Education remains low among our churches. In fact, nationwide, only 17% of churches give anything to the cause of Christian Higher Education. I remain convinced that a thinking Christian leader poses a greater threat to the kingdom of darkness than anything else. Yet, we persist in under-resourcing the work of developing "thinking centers." Trinity is one such center. I appeal for your ongoing support.

Sectional Presbyters will provide the nomination results to the Secretary-Treasurer. The Network Presbytery, serving as the vetting committee, shall be entrusted with the responsibility of making investigation into the qualifications of nominees and shall select viable candidates to be presented to the voting constituency for election at the Network Council or special meeting in session. All candidates shall be balloted upon until a candidate receives two-thirds of the vote. If a two-thirds vote has not been obtained by the first three ballots taken, the two candidates having the highest number of votes in the last ballot cast shall be nominees to be further voted upon and all other names shall be eliminated. In the event any nominee, at the time of the elective process, receives no votes, his/her name shall be automatically eliminated from the nominee slate.

John and Dawn married in 1991 and spent their early years in ministry serving on staff as children's, youth, and associate pastors with Austin Bluffs Community Church in Colorado Springs and First Assembly of God in Greeley, Colorado. John and Dawn also served as lead pastors for 14 years at Potomac Valley A/G in Germantown, Maryland. In 2011, John graduated with a Master of Arts in Christian Ministry degree from Assemblies of God Theological Seminary. In 2017, God led John and

and Dawn back to the Rocky Mountain Network where they served as lead pastors at First Assembly in Greeley, Colorado until being unanimously appointed by the District Presbytery to serve as the District Secretary/Treasurer effective January 1, 2021. John served as the RMMN Secretary/Treasurer until February 2025. John and Dawn have two grown children, an awesome son-in-law (who became the next lead pastor at Greeley First Assembly), and four grandchildren who affectionately call them "Mimi" and "Popi." John and Dawn have a passion to serve the Church and to help individuals discover their true purpose in Christ while walking out their lives in spiritual and emotional health.



Gene Roncone (132 nominations). Gene Roncone has served as the District Superintendent and Network Pastor of the Rocky Mountain Ministry Network since his election in April 2019. TERM OF OFFICE

Section 1. Executive Officers

a. Officers and Terms of Office. The officers shall consist of the Superintendent aka: Network Pastor, the Assistant Superintendent, the Secretary-Treasurer, together with three (3) Field Executive Presbyters. Their terms of office shall begin one month after the vote of election. The term of each Executive Officer shall continue for three years or until a successor qualifies.

Bylaws, Article V, Section 1a

NOMINATION & ELECTION

c. Field Executive Presbyters. The selection process for Field Executive Presbyters shall be based on geographical region. Each section within the geographical region may nominate one name from within that geographical region during their Sectional Council. Nominations shall be by secret ballot. Those receiving a simple majority shall be presented to the next Ministry Network Council for consideration as Field Executive Presbyter from their geographical region. The names of nominees for Field Executive Presbyter shall be ratified first by the Network Presbytery. If any region should not have any names to present to the Ministry Network Council, the Network Presbytery shall present at least one qualified name for consideration at Ministry Network Council. A two-thirds vote of the Ministry Network Council shall be required for election. The entire voting constituency of the Ministry Network Council shall vote on all the Field Executive Presbyters by geographical regions.

SECTIONAL PRESBYTER

QUALIFICATIONS

(1) Presbyters shall be ordained ministers within their geographical section. The Executive Presbytery shall be authorized to appoint or present to a section for election, an ordained minister from a neighboring section when qualified ministers within that section are unwilling to serve or if there are no qualified ministers to serve.

Bylaws, Article V, Section 3d (1)

SECTIONAL PRESBYTER cont.

RESPONSIBILITIES

Sectional Presbyter. Each geographical section shall elect a Presbyter who shall:

- (1) Serve on request and in cooperation with the Superintendent aka: Network Pastor in conducting official business within the section.
- (2) Arrange for and preside at sectional meetings.
- (3) Serve on the Board of Network Affiliated Churches in their section.
- (4) Fulfill responsibilities outlined in the Policy and Procedure Manual.
- (5) Be amenable to the Executive Presbytery.

Bylaws, Article V, Section 3a (1-5)

TERM OF OFFICE

(1) Presbyters shall serve a three (3) year term. Bylaws, Article V, Section 3c (1)

NOMINATION & ELECTION

a. Presbyter and Committee. Each section at the annual Sectional Council shall nominate and elect by secret ballot a Sectional Presbyter and two (2) Sectional Committeepersons according to each section's three-year cycle. A two-thirds vote shall be required for election. One third of the presbyters shall be elected each year. Sectional Presbyters shall be ratified first by a two-thirds vote of the Network Presbytery and then by a two-thirds vote of the Ministry Network Council in session.
